



# Biographies for Main Congress Day One

## Professor Federico (Freddie) Corletto

Professor Federico (Freddie) Corletto is an EBVS and RCVS Recognised Specialist in Veterinary Anaesthesia and Analgesia, and Fellow of the Royal College of Veterinary Surgeons. Freddie qualified with honours from Padua Vet School in 1997. He undertook his residency training at the Animal Health Trust, obtaining his RCVS Certificate in Veterinary Anaesthesia in 2002 and the European Diploma in Veterinary Anaesthesia and Analgesia in 2003. In 2011 he completed a PhD on traumatic brain injury, based at the School of Medicine of Cambridge University (Anaesthetic Division). He has worked in academia (Padua University, Cambridge University), at the Animal Health Trust and in 2008 joined Dick White Referrals, where he founded and run the anaesthetic service for 14 years, until he left in 2023. He holds a part time Chair in Veterinary Anaesthesia and Analgesia at the University of Nottingham and has been President of the European College of Veterinary Anaesthesia and Analgesia. He is one of the founding partners of Granta Veterinary Specialists, where he currently works.

## Professor Jennifer M. Hunter

Professor Jennifer M. Hunter is Emeritus Professor and Senior Research Fellow in the University of Liverpool. She graduated with commendation from the University of St. Andrews in 1971. Her research interests are the pharmacodynamics and pharmacokinetics of neuromuscular blocking drugs in health and disease. Her clinical responsibilities have included the management of the critically ill and patients with chronic kidney disease. Professor Hunter has been Honorary Secretary of the Anaesthetic Research Society (1991-6) and in 1997 became Editor-in-Chief of the BJA. She was Chair of the Scientific Programme Committee of the ESA from 2006 to 2009, and in 2016 was made an Honorary Life Member of the Society. She has over 240 peer-reviewed publications and has edited three textbooks. She was awarded the Gold Medal of the Royal College of Anaesthetists in 2011; and was made a Member of the Order of the British Empire by the Queen in 2015.

## Professor Ronald S. Jones, OBE, JP, MVSc, DrMedVet, DVSc, DVA, DipECVAA, DipACVAA, FSB, FLS, FRSA, FRCA, FRCVS.

Professor Jones graduated from Liverpool in 1960 and after a spell in mixed practice joined the staff of the Glasgow Veterinary School. In 1962 he returned to Liverpool to the first designated lectureship in Veterinary Anaesthesia in the Department of Anaesthesia (Medical and Veterinary). His main but not exclusive research was in the area of muscle relaxants in animals and man, from which he produced over 200 publications. He progressed to a personal professorship and ultimately to head of department, He served as Dean of the Faculty of Veterinary Science and was



elected President of the Royal College of Veterinary Surgeons. Nationally he served on the Medicines Commission and the Advisory Council on the Misuse of Drugs. He was awarded an honorary Fellowship by the Royal College of Anaesthetists and granted honorary diplomate status by the American College of Veterinary Anesthesia and Analgesia. In 1998 he was appointed an Officer of the most noble Order of the British Empire. In retirement he was appointed chairman of the Farriers Registration Council and pursued his hobby of allotment gardening and was recently appointed a life Vice-President of the National Allotment Society. He still continues his support of Liverpool Football Club.

## **Dr Jane Quinlan**

Dr Jane Quinlan studied medicine and trained in anaesthesia in London before moving to Oxford. She is a consultant in anaesthesia and pain management at the Oxford University Hospitals NHS Foundation Trust and is an honorary senior clinical lecturer at the University of Oxford. She is past secretary of the Acute Pain Special Interest Group (APSIG) for the International Association for the Study of Pain and past chair of APSIG of the British Pain Society. Jane has an interest in prescribed opioid dependence and runs a clinic supporting pain patients to reduce high-dose opioids. She also has an interest around the safe prescribing of opioids in postoperative pain to avoid the conversion to long-term use. She sits on the editorial board of the British Journal of Pain and is on the organising committee of the National Acute Pain Symposium.

## **Professor Patrice Forget M.D. Ph.D.**

Professor Patrice Forget, M.D. Ph.D., has worked as Clinical Professor in Anaesthesia and Pain Medicine in Belgium, and as President of the Belgian Pain Society. In 2019, he has been appointed as Clinical Chair in Anaesthesia at the University of Aberdeen (UK), and Honorary Consultant at the NHS Grampian.

He is involved in clinical research, focused on mainly pain, perioperative epidemiology and clinical pharmacology. For the last ten years, as principal investigator and/or national coordinator, he published more than 150 articles, letters or editorials.

He is the Chair of the PANDOS (Pain AND Opioids after Surgery) ESAIC Research Group (European Society of Anaesthesiology and Intensive Care).

Board Member of the European Pain Federation EFIC (Honorary Treasurer, Chair of the Societal Impact of Pain partnership with the Pain Alliance Europe)

Active member of the European Society of Anaesthesiology and Intensive Care (ESAIC), deputy Editor-in-Chief of the European Journal of Anaesthesiology, Acute and Chronic Pain Subcommittee member.

Past President of the Belgian Pain Society.

## **Doctor Sibs Anwar M.D. Ph.D.**

Sibs is a Consultant Cardiothoracic Anaesthetist, Intensive Care Specialist and Pain Physician at the Barts Heart Centre and Cleveland Clinic London. He conducts translational and clinical research at the Barts NIHR Biomedical Research Centre focussing on the mechanisms of transition from acute to chronic pain states following cardiothoracic surgery. He is an Editor for the Journal of Cardiothoracic and Vascular Anesthesia and Visiting Professor of Cardiac Anesthesiology at Harvard Medical School.

## **Dr. Miguel Gozalo-Marcilla, DVM, PhD, Dipl. ECVAA, MRCVS.**

Miguel graduated as a veterinarian at the University of León (Spain) in 2004. After 2 years working in the equine referral practice “Hospital Veterinario Sierra de Madrid” in Spain, he

he moved to Belgium from 2007 to 2014. Within that period, he obtained the Diploma from the European College of Veterinary Anaesthesia and Analgesia (ECVAA), as well as his PhD from Ghent University, whose doctoral title was “Dexmedetomidine for balanced anesthesia in horses”.

From 2015 to 2018 Miguel moved to Brazil and led a post-doctoral fellowship project at the São Paulo State University (UNESP) of Botucatu. His international research team evaluated the sedative and antinociceptive effects of different combinations of the alpha-2 agonist detomidine and the opioid methadone.

In September 2018 he joined the Department of Anaesthesia and Analgesia of the Royal (Dick) School of Veterinary Studies and The Roslin Institute, The University of Edinburgh as a Senior Lecturer in Veterinary Anaesthesia and Analgesia. Since then, and based on his research interests, Miguel is one of the founding members of the scientific research group “Confidential Inquiry into Perioperative Equine Fatalities – Community Interest Company (CEPEF CIC)” together with Dr. Polly Taylor, Prof. Regula Bettschart-Wolfensberger, Dr. Mark Johnston and Prof. José Ignacio Redondo García. This research group aims to coordinate multicentre, epidemiological scientific studies focused on the study of veterinary anaesthetic mortality, among others.

Miguel has published numerous research, review, and clinical articles in peer-reviewed veterinary. He lectures regularly at national and international courses/conferences mainly in equine anaesthesia. In addition, he is an active member of the SEAAV (Spanish Society of Veterinary Anaesthesia and Analgesia), the AVA (Association of Veterinary Anaesthetists) and an honorary member of the Mexican College of Veterinary Anaesthesiology and Analgesia.
